- 2. Erosion control measures shall be installed and maintained to Pierce County and State codes prior to commencing any excavation. In performing any grading, site improvements, or construction upon the premises, adequate provision shall be made for handling the run-off of surface waters in a manner which will not damage streets or adjoining properties, and at all times, construction shall be conducted in such a manner as to preserve lateral support for adjoining properties and prevent any significant adverse impact to adjacent lots.
- 3. Construction shall be completed in accordance with the approved plans and comply with the <u>Covenants, Conditions, and Restrictions, and Easements</u> For the Wildview HOA Planned Development District.
