WVR HOA BOARD MEETING MINUTES

Date: November 13, 2007

Meeting Called to Order: Lain Knowles called the meeting to order at 6:405 p.m.

In attendance: Lain Knowles - President, Jay Hambly- Vice President, Tiana Gaulke - Alternate,

Minutes of previous meeting: Approved by Jay Hambly second by Tiana Gaulke

Financial Report: Presented by Denise for JC Higgins.

> 2 out of 42 Homeowners are delinquent in payment of the second half HOA dues that were due in July. The normal 3 letter collection process is being followed. The third and final collection letter has been sent and a lien will be placed on the property if not

paid by November 30, 2007.

The maturing Certificate of Deposit was renewed with an additional amount from reserves to bring it to \$10,000. It is the Boards intention to have four CD's maturing at various times over the year (one each quarter). The base amount of each CD will be

\$10,000 plus accrued interest when renewed.

As of October 30, 2007, the Association has \$21,030 in savings and \$9,046 in

unallocated reserves. Total value of CD's is \$24,247.

Lain Knowles moved to accept financial statements as presented; second by Jay

Hambly. Passed.

Homeowners/guest issues: There were no Homeowners or guest issues brought to the meeting.

OLD BUSINESS:

Landscaping Committee

Concerns expressed by the Landscaping Committee about the front area landscaping were brought to the attention of Epic Landscaping. Epic said that anyone with any concerns should let them know and can also come talk to them on Saturdays, when they are at the front working. The contract was renewed with Epic for 2008. The Board will ask the Landscaping Committee to bring any concerns to the attention of Epic so

they can be addressed as soon as possible.

A contract amendment is being signed by Epic – Denise will follow up to get it signed.

The Landscaping Committee will be asked to decorate the gate area for the holidays.

 Social Committee There is a candle party at the Gaulke's during November. The Social Committee will

investigate neighborhood interest in Christmas caroling.

It was suggested that the Committee put together an updated "Who do you call" list for posting at the mailboxes. Lain pointed out that there is a list on the website, as well.

Finance Committee

The Finance Committee met and developed the proposed 2008 budget. A copy of the budget will be sent to homeowners with the Annual Meeting materials. It will be voted on and passed at the meeting.

Gate issues

The Board voted to accept the maintenance proposal by AE Gates Company for one year to see if the scheduled maintenance would reduce the repairs on the gate. A contract was signed for 2008 and AE Gates Company will come out twice per year to perform preventative maintenance on the gates. They will also be the primary provider for emergency service. HC Higgins was instructed to use them for all emergency repairs.

Well house issues

Blueline Water performed services on the tanks located in the C-D and B-I well houses during the first part of November. They also flushed the main lines afterward. John McAuliffe will follow up with Blueline to get a report on their recommendations.

The Wells Committee will flush the remaining systems that were not done by BlueLine Water during December.

John took an action item for the well committee to explore some emergency power generator scenarios for the community wells and is working with PSE to determine cost of running natural gas lines to the well houses for backup generators.

The Wells Committee should check to see that the heaters are on in the well houses now that the cold weather is coming.

Community safety issues

Homeowners are reminded to obey speed limits in the neighborhood. We have received several complaints about cars speeding in the neighborhood – please remember it is dark earlier and kids are hard to see.
